Authorization Required for a Strata Property

- Strata Council Minutes or a Resolution that authorize the Applicant (by name) to access and copy plans;
- OR**
- Signed authorization from the Strata Management Company.
- AND**
- If the Applicant is not an owner on title for the property, they must submit a complete [Authorization Form](#) with their application.
